## SERVING THE COMMUNITY



**Donald & Claire Brown**

**The Donald E. and Claire E. Brown Fund** was created by family and friends to honor the couple for their dedication to the field of education. Donald Brown received his undergraduate degree from North Central College in Naperville and a Master of Science degree from Northwestern University. In 1936, Mr. Brown was hired by East Aurora High School as a bookkeeping teacher and their first wrestling coach. In 2002, he was inducted into the East Aurora High School Athletic Hall of Fame. After retiring from East High, Mr. Brown taught at Aurora College for nine years. Claire Brown (1914-1992) was born in Pittsfield, Illinois. She attended North Central College from 1932-1934. She then devoted the next thirty years of her life as a loving wife, mother and community volunteer. In 1952, she received her undergraduate degree from Aurora College. For the next twenty-two years, she taught first grade. Most of her teaching career was spent at McCleery Elementary School in Aurora.



**Kathleen McCalla**

**The Kathleen Ann McCalla Memorial Fund** will provide grants for anti-smoking educational programs that will benefit the students of West Aurora High School. The fund was created by Kathleen's mother, three sisters, friends and co-workers. Kathleen McCalla (1949-2005) was a 1967 graduate of West Aurora High School. She was an active participant in the gymnastics program while a student at the school. She was employed by the Federal Aviation Agency in Aurora for twenty-one years. According to her family, a memorial fund was established out of concern for the health and welfare of students who are not aware of the serious hazards of smoking. It is the intention of this fund to bring innovative programs to the high school that will significantly impact the decisions students must make in this important area of their lives. Kathleen will be remembered for her kindness, generosity and love of family. She also will be remembered for the legacy she leaves for the benefit of others.



**Richard & Marilyn Michelini**

**The Richard J. and Marilyn J. Michelini Scholarship Fund** was created to provide scholarships to students who reside within the incorporated area of the Village of Montgomery. Richard Michelini (1931-2003) was a graduate of Colorado State University. He served in the United States Army and was regional sales manager for Ciba-Geigy for thirty-three years. Mr. Michelini served on the Montgomery Village Board and also was chairman of the Aurora Township Democratic Party. Marilyn Michelini is the president of the Village of Montgomery. She is a member of the DuKane Valley Council, Kendall County Mayors and Managers Association, Metro West Council of Governments, Kane County Storm Water Management Commission and United Way of the Fox Valley. Previously, she served on the Kane County Board and the Village of Montgomery Board of Trustees. The Michelinis have five children. Mrs. Michelini created this scholarship fund as a tribute to her husband and as a meaningful way to assist the residents of the community she serves.



**Robert Mukensturm**

**The Robert G. Mukensturm Endowment Fund** was established upon the receipt of a generous bequest from the estate of Mr. Mukensturm. The fund will provide income for the general purposes of the Foundation and will support grants to charitable organizations in the community. Robert Mukensturm (1920-2004) was born in Deerfield, Michigan. He graduated from the Alexian School of Nursing in 1942. He then served in the United States Navy. Following his discharge from the Navy in 1951, he worked for the Aruba-Standard Oil Company. Mr. Mukensturm subsequently became associated with St. Charles Hospital in Aurora for ten years as a Nurse Anesthetist. He then joined the practice of Gillette, Starshak and Colletti at the Aurora Dental Arts Clinic and remained with the clinic for twenty-five years. He was a member of the Aurora Turner's Club, Amvets Post 103 and the Yorkville American Legion Post 489. Mr. Mukensturm will be remembered for years to come for his generous provision for the future charitable needs of the community.



**Merrill & Frances Olson**

**The Merrill E. and Frances C. Olson Endowment Fund** was established upon the receipt of a bequest from the estates of Merrill and Frances Olson. The fund will distribute income for the general purposes of the Foundation. Merrill Olson (1919-1987) was born in Mankato, Minnesota. He was a graduate of Gustavus Adolphus College and attended St. Paul College of Law. Mr. Olson worked for the William H. Ziegler Company of Minneapolis until 1962 when he moved to Aurora. He retired in 1977 as a vice-president of the Barber-Greene Company. Frances Olson (1911-2004) was born in Amboy, Minnesota. She was a graduate of Amboy High School and attended Mankato State Teachers College for several years. Mrs. Olson was an active member of Wesley United Methodist Church, the White Cross Auxiliary of Copley Memorial Hospital and the Child Welfare Society. She also served on the United Way of the Aurora Area Board of Directors.



**Clarence Ruddy**

**The Clarence J. Ruddy Memorial Scholarship Fund** was created to honor the life of Clarence Ruddy, a prominent Kane County attorney and civic leader. Mr. Ruddy (1905-2004) was a graduate of East Aurora High School. He received his undergraduate and law degrees from the University of Notre Dame, where he founded and became the first editor-in-chief of the Notre Dame Lawyer (now known as the Notre Dame Law Review). Attorney Ruddy practiced law in Aurora from 1927 until his retirement in 1985. He remained "Of Counsel" to the firm of Myler, Ruddy & McTavish until his death. Mr. Ruddy served as an Illinois Assistant Attorney General from 1933 to 1941, a Special Assistant Attorney General from 1961 to 1969 and president of the Kane County Bar Association from 1944 to 1945. An active civic leader, he was one of the original founders of The Aurora Foundation. He also served as president of the Aurora War Fund in 1943 and 1944, president of the Aurora Chamber of Commerce and fundraiser for numerous community charities. Attorney Ruddy was preceded in death by his wife, Dorothy. The couple is survived by three children.

## PRIVATE FOUNDATION CONTINUES TO SERVE



**Percy & Grace Council** provided significant support to charitable organizations in the name of Percy and Grace Council.

Elizabeth Hendrickson, board secretary and niece of Percy and Grace Council, stated that the time had come to dispense with

the details involved in running a private foundation.

"My aunt and uncle would have been pleased to have an advised fund within The Aurora Foundation. The income will continue to benefit the non-profit organizations in which the Councils were interested," said Mrs. Hendrickson.

In 1999, a distribution from the private foundation to The Aurora Foundation created the Percy R. and Grace M. Council Endowment Fund which provides income for the general grantmaking purposes of The Aurora Foundation.

Percy Council (1893-1982) was a building contractor and realtor. Mr. Council was instrumental in developing the Cherry Hill Estates in West Aurora.

Grace Council (1901-1997) was an educator and chair of the Department of Education at Aurora College. In her retirement, she served on the Citizens Advisory Board of Aurora University and was an active travel agent.

The Aurora Foundation is proud to administer this charitable fund that will continue to honor Mr. and Mrs. Council for their extraordinary dedication to the Aurora community.
