## IN GRATEFUL TRIBUTE



**Charlotte Reid**

**The Charlotte T. Reid Memorial Scholarship Fund** provides scholarships to students entering the field of music. Charlotte Reid (1913-2007) was born in Kankakee, Illinois. She attended Illinois College in Jacksonville and studied music with Louise Gilbert of Chicago. Later, she was a featured vocalist on the nationally syndicated radio program on NBC, the Don McNeil Breakfast Club. When her husband Frank Reid died after winning the Republican Primary for the United States Congress in 1962, Mrs. Reid was chosen to run in his place. She won and was re-elected four more times. In the middle of her fifth term, she was appointed to the FCC. Mrs. Reid addressed the National Republican Convention in 1964 and 1968. She is survived by two daughters, Patricia Lindner and Susan Lewis, and by her son, Frank.



**Dustin Villarreal**

**The Dustin Villarreal Family Memorial Scholarship Fund** was established by the parents of Dustin Villarreal (1991-2006) as a tribute to this young athlete's life. Dustin was a freshman at Geneva High School pursuing his dream to win a state championship and play college football. He loved to compete in sports and had an outstanding work ethic on his teams. One of the Geneva football coaches stated, "As good a football player as he was, he was a better kid. He just really epitomized what we look for out of a Viking." Dustin's friends characterized him as "a great kid who was always looking out for others, who was always smiling." Dustin passed away unexpectedly from an undetected heart ailment. He is survived by his parents, Dave and Jena, and his brother David. Scholarships from this fund are awarded to Geneva High School graduates who participated in varsity football, have good leadership skills and have demonstrated service to community and/or church. The family would like to help others pursue their dreams.



**Howard & Sherry Eagle**

**The Howard and Sherry Eagle Scholarship Endowment Fund** provides scholarships to students graduating from West Aurora High School for attendance at Aurora University. Howard Eagle (1946-2006) was born in Chicago, Illinois. He began his career as a small business owner and later became an educator at the Aurora Community School. He was an inspiring teacher who challenged his students to reach for a future that would bring hope and promise to their lives. Sherry Eagle is currently the executive director of the Institute for Collaboration at Aurora University. She served as superintendent of West Aurora School District 129 for twelve years. Howard and Sherry Eagle encouraged students to find their place in the world by believing in themselves. It is in this spirit that scholarships from their fund are awarded.



**Louis Forte**

**The Louis R. Forte Music Scholarship Fund** was created by his family to honor his thirty-seven years of service as a music educator. Louis Forte (1925-2006) taught at Simmons Junior High School and East Aurora High School. Upon retirement, he continued to teach part-time at Holy Angels Catholic School and also in the West Aurora School District at Jefferson, Washington, Jewel and Herget Schools for a total of eighteen additional years. Mr. Forte received his undergraduate degree in music from Vandercook College of Music in Chicago and his masters degree in music education from Northwestern University. Scholarships from this fund are awarded to students from East or West Aurora High Schools who are pursuing a degree in music at the college level of study. Mr. Forte's commitment to bringing out the very best talent in each student is the basis for the awarding of these scholarships.



**Richard Rokop, Sr.**

**The Richard H. Rokop, Sr. Memorial Scholarship Fund** provides scholarships to residents of the City of Aurora, the Village of North Aurora and Aurora Township who are enrolled at the undergraduate level of study at a college or university. Richard Rokop (1941-2006) was born in Aurora, Illinois. After graduation from East Aurora High School, he began a thirty-year career at Northern Illinois Gas Company. Mr. Rokop was a member of Holy Angels Catholic Church, the Lions Club and the Phoenix Club. He served as a Kane County Republican Treasurer and was a member of the Fox Metro Water Reclamation District Board of Trustees. In honor of his longtime commitment to coaching, Mr. Rokop was inducted into the Illinois Basketball Coaches Association Hall of Fame. He is survived by his wife, Jeanne, and three sons, Richard, Jr., Michael and Daniel.



**The Kiwanis Club of Aurora, Illinois Endowment Fund** supports the philanthropic purposes of the Kiwanis Club of Aurora. The local club was organized in 1916, the 21st

Kiwanis Club to be chartered in the world. Kiwanis is a coined word meaning "stand tall" derived from the Sioux Indian language.
