## NEW CHARITABLE FUNDS



**August Fischer**

The **August W. Fischer, Jr. Scholarship Fund** provides scholarships to local graduating high school students who are entering the field of accounting at Aurora University. August Fischer (1926-2007) lived his entire life in Aurora. He was educated in the East Aurora School System. He then worked as a draftsman and design engineer for several Aurora companies, including Lyon Metal and McKee Door. While at McKee Door, he was manager of engineering. Mr. Fischer was a skilled woodworker who enjoyed making beautiful wood projects for his home and family. He also was an accomplished preparer of German delicacies. He is survived by his wife, Delores Fischer, and two daughters, Jane Price and Julie Bromann, both of Aurora.



**Robert & Helen Mitchler**

The **Senator Robert W. & Helen Drew Mitchler Scholarship Endowment Fund** provides scholarships to students entering the field of nursing. Robert and Helen Mitchler are both natives of Aurora and graduates of East Aurora High School. Mr. Mitchler graduated from Aurora College and Mrs. Mitchler from the Copley Hospital School of Nursing. Robert Mitchler was employed with the CB&Q Railroad and Northern Illinois Gas Company. He is a United States Navy veteran of World War II and the Korean War. He was elected to the Illinois State Senate and appointed to serve with the Illinois Department of Veterans Affairs. Mrs. Mitchler's career in nursing was with Copley Memorial Hospital and the Dreyer Medical Clinic. Both have been active in community service—Robert Mitchler serving with numerous military and veteran organizations and Helen Mitchler with social, political and medical support units. Mrs. Mitchler's active work with the National Society Daughters of The American Revolution earned her election as National Vice President General. Since 1953 they have lived in rural Oswego in Kendall County.



**Ted & Abby Laatz**

The **Laatz Family Foundation** was established by Ted and Abby Laatz to support the efforts of charitable organizations throughout the Aurora/Fox Valley area which contribute to the physical, educational and spiritual well-being of children and youth. Ted Laatz, a life long resident of Aurora, is a graduate of Marmion Military Academy and Bradley University, where he earned a degree in business administration. He is co-owner and vice president of the RE/MAX Great American/RE/MAX Town & Country companies. In addition, Mr. Laatz is past president of the Aurora Tri-County Association of Realtors and is currently a member of the Marmion Academy Alumni Board and the Rotary Club of Aurora. Abby Siegert Laatz, originally from Rock Island, Illinois, graduated from Bradley University with a degree in psychology. She continued her education at the Montessori Education Centers Associated in Hinsdale, Illinois. Mrs. Laatz was a teacher in the Aurora area and created an E-Commerce business in the years following the birth of their two sons. She now is serving the community as a volunteer for several organizations.



**Eldon & Evelyn Rackmyer**

The **Eldon R. & Evelyn E. Rackmyer Parochial Schools Endowment Fund** was created to assist St. Rita of Cascia School in Aurora. Eldon Rackmyer (1912-1991) was a lifelong Aurora resident. He was a graduate of East Aurora High School and worked as a conductor for the CB&Q Railroad. Both his father and grandfather served as aldermen for the City of Aurora. Evelyn Rackmyer was born in Richmond, Illinois. At the age of three, her family moved to Aurora. She attended Sacred Heart Grade School and Madonna High School. After graduation from East Aurora High School, Mrs. Rackmyer worked as clerk-steno for the CB&Q Railroad. She currently is a member of the staff of the Aurora Public Art Commission and has volunteered for numerous charitable organizations, including St. Rita of Cascia Church.



**Edward & Gladys Arenkill**

The **Edward and Gladys (Stoddard) Arenkill Nursing & Medical Education Scholarship Endowment Fund** was created to assist students pursuing a pre-medical course of study or a degree in the field of nursing. Edward Arenkill (1922-2007) was a lifelong Aurora resident. He graduated from Aurora East High School and was a medical corpsman in the United States Navy during World War II. His four years of active duty included both Normandy and Okinawa. Mr. Arenkill studied pre-medicine at Northwestern University, and later joined his father and brother in their Aurora family business. Gladys Stoddard Arenkill (1923-2004) was born in Nebraska. She was a graduate of the Copley School of Nursing in Aurora. She was a nurse at Copley Memorial Hospital and a private duty nurse providing care for iron lung patients. Following her career, she contributed over 3,000 hours of volunteer service at Copley Memorial Hospital. Mr. and Mrs. Arenkill were members of Fourth Street Methodist Church.



**J. William & Arline Hoban**

The **Dr. J. William and Arline Hoban Family Fund** was established to assist local students who are furthering their education at a college, university, vocational or trade school. Dr. Hoban (1920-2003) received his master's degree from the University of Detroit and his doctorate from Wayne State University. He and his wife Arline moved to Aurora in 1968 at which time he became Dean of the Evening School and Summer School at the newly organized Waubensee Community College. He retired from the college in 1989. Arline Hoban is a graduate of the University of Detroit. She was an educator at West Aurora High School and later began a career at MetLife. Mrs. Hoban retired in 1990. She currently is a member of Holy Angels Church and the American Association of University Women. Dr. and Mrs. Hoban have six children. The scholarship fund created by the Hoban Family reflects their dedication to higher education.

### LOCAL EDUCATOR REMEMBERED

The Stanley F. Karnoscak Memorial Scholarship Fund was created by Mr. Karnoscak's family and friends to honor the life of this extraordinary educator. Stanley Karnoscak (1952-2008) was born in Chicago, Illinois. He received his undergraduate and graduate degrees from Northern Illinois University. He began his career in the West Aurora School District in 1974, teaching at several elementary schools and at Herget Middle School. In 2000, he was named "Illinois Art Educator of the Year." Mr. Karnoscak also was an instruc-
